- Ensure that all traders adhere to regulations of the market
- Aid the safe passage of all deliveries to the Market site, assisting the operations team as needed
- Take responsibility for lost property found in the Market, logging and storing it appropriately and returning it to owners where possible
- Checking with film crews that they have permission to be in the Market, and if they don't have appropriate documentation, directing them to the process they need to follow
- Liaising with traders to ensure that the security team are aware
  of any issues arising, collecting details for overnight deliveries,
  receiving deliveries on behalf of traders and contributing to the
  smooth running of the Market
- Reporting of any Market incidents to the Head of Operations in a timely manner
